A Nicor Gas system improvement initiative

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, has been working to modernize the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of our work. **Ensuring the safety of every family we serve is our highest priority. With the ongoing COVID-19 pandemic, please know that our employees and contractors are continuing to take precautions when interacting with customers as recommended by the Centers for Disease Control and Prevention (CDC), including avoiding handshakes, maintaining a 6-foot distance and wearing protective gear when necessary and appropriate.**

### Our Progress

In September, Nicor Gas, with its contractor NPL, completed the installation of a new natural gas main in your neighborhood as well as new natural gas service lines which connect each customer's property to the natural gas main. Now that the new natural gas service lines have been installed and the new system is connected, we will be performing a series of inspections on the new system as part of our standard safety and quality assurance practices. While we anticipated these inspections to begin immediately following construction, our crews experienced some minor delays due to the pandemic and other operational conditions.

### Completing Our Work

Now that the new natural gas main has been installed, Nicor Gas' contractor, Vector Services, will be performing a video inspection of your sanitary sewer lateral and storm lateral (if applicable). We are completing this inspection as a safety precaution to ensure that your existing sanitary sewer and/or storm laterals are not in conflict with the newly installed natural gas main or service line. If your service and/or storm lateral are accessible from the street, there is no action required from you for this inspection.

If your sewer service and/or storm lateral are not accessible from the street or outside your home, Nicor Gas' contractor, Vector Services, will contact you to schedule an appointment to inspect the sewer line from inside your property. There will be no interruption to your natural gas or sewer service during the inspection.

### For Your Safety

These improvements are part of the Natural Gas Consumer, Safety & Reliability Act and costs are recovered under the Qualified Infrastructure Charge. All Nicor Gas employees and contractors will have Nicor Gas, AGL Resources or Southern Company Gas-issued ID cards and will present them if requested. The Nicor Gas contractors working on this project are NPL, UMI and Vector Services.

### Our Commitment

We take great care in implementing construction practices that limit disturbances and we understand your time is valuable. We appreciate your understanding and thank you for allowing us to continue to provide you with safe and reliable natural gas service.
