
Purpose:

The purpose of this document is to provide detailed instructions for a first-time user to log into the Nicor Gas Nomination System.

Instructions:

- To access the Nicor’s Gas Nomination System, type <https://noms.nicor.com> in the web browser. The Gas Nomination Website Login Page will display.



| Field | Function |
|-----------------|--|
| User ID | Enter the User ID that was e-mailed to you. |
| Password | Enter the temporary password that was e-mailed to you. |
