## to your natural gas system in Elmhurst

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, has been working to modernize the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of the status of our work.

### Our Progress

Nicor Gas with its contractor, NPL, has completed the installation of a new 20" natural gas main on Madison St. between Hawthorne and Parkside Aves. During this project it was discovered that a segment of water main will need to be replaced for safety purposes. The City of Elmhurst, with its contractor Gerardi Sewer & Water Co., will begin replacing the water main on Madison St. between Hawthorne Ave. and Spring Road beginning Monday, October 23. After the water main is replaced, new curbs will be installed and pavement and landscaping restoration will begin shortly thereafter. Temporary restoration of some areas may be necessary until permanent restoration can be completed.

### Expected Timeline of Work (Weather Permitting)

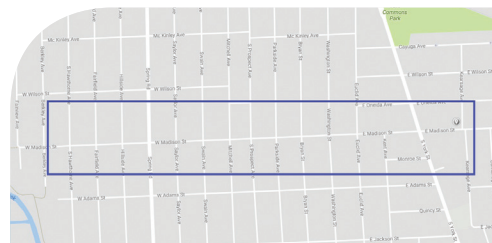
- **Week of October 23, 2017** – Installation of new water main and curb replacement will begin and continue through the week of October 30.
- **Week of November 6, 2017** – Road repair begins on the north traffic lane of Madison St. Parkway restoration also begins this week.
- **Week of November 13, 2017** – Repaving of Madison St. from Hawthorne Ave. to Parkside Ave. begins.

### For Your Safety

These improvements are part of the Natural Gas Consumer, Safety & Reliability Act and costs are recovered under the Qualified Infrastructure Charge. All Nicor Gas employees and contractors will have Nicor Gas, AGL Resources or Southern Company Gas-issued ID cards and will present them if requested. The Nicor Gas contractor working on this project is NPL.
