# Safety Moment: Brain Injury



MARCH IS  
**BRAIN INJURY**  
AWARENESS MONTH

- Over 5.3 million individuals in the United States live with a permanent brain injury-related disability. That's one in every 60 people.
- At least 2.8 million Americans sustain traumatic brain injuries in the United States every year.

What is the most common type of brain injury?

Concussions are the most common. They are caused when the brain is impacted by blows or wounds, and the person typically feels dazed if they retain consciousness. It may go undiagnosed if proper care is not taken.

What are some causes of non-traumatic brain injuries?

It may be the result of stroke, diseases such as meningitis or encephalitis, seizures, electric shocks, tumors, lead or carbon monoxide poisoning, drowning, and choking among other causes.

- Soothing music can release oxytocin in the brain.

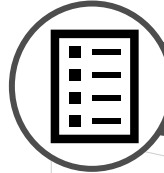
