Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, has been working to modernize the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of the status of our work.

Our Progress

Nicor Gas with its contractor, NPL, has completed the installation of a new 20" natural gas main on Madison St. between Hawthorne and Parkside Aves. During this project it was discovered that a segment of water main needed to be replaced for safety purposes. The City of Elmhurst, with its contractor Gerardi Sewer & Water Co., has completed the installation of the new water main. Nicor Gas is currently restoring pavement and landscaping in the area. Nicor Gas and NPL will continue the main replacement on Madison St. between Parkside and Poplar Aves.

Expected Timeline of Work*

- **Week of June 11, 2018** – Nicor Gas' contractor, NPL, will begin conducting sewer inspections as part of Nicor Gas' safety practices. If your sewer service is not accessible from the street, NPL will schedule an appointment to inspect the sewer line from inside your property. There will be no interruption to your natural gas or sewer service during the inspection. Vital information from the inspection will be marked on lawns and sidewalks with spray paint to avoid any interference with your sewer lines. NPL will also locate and mark other utilities. During this step, water, sewer, electric and cable utilities will be located and identified with spray painted markings and colored flags. It is important that these markings always remain visible for your safety. Private utility lines, such as sprinkler systems, are your responsibility to identify and mark at the time other utilities are marked.
- **Week of June 25, 2018** – Main replacement will continue on Madison St. between Parkside and Poplar Aves. Detour signage and other traffic control devices will be set up for residents prior to street closures. Nicor Gas is working closely with community leaders to reduce the impact this work has on local roads and other pathways.
- **October 2018** – Main replacement is expected to be completed.

We understand that you value the appearance of your property. Nicor Gas will restore landscaping and paving impacted by our construction to the condition in which we found it. Temporary restoration of some areas will be necessary until permanent restoration can be completed.

For Your Safety

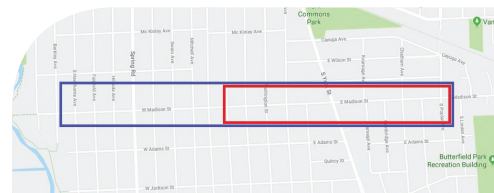
