Enhancements to your natural gas system in Elmhurst

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, has been working to modernize the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of the status of our work.

Our Progress

Nicor Gas with its contractor, NPL, has completed the installation of a new 20" natural gas main on Madison St. between Hawthorne and Parkside Aves. During this project it was discovered that a segment of water main needed to be replaced for safety purposes. The City of Elmhurst, with its contractor Gerardi Sewer & Water Co., has completed the installation of the new water main and Nicor Gas is currently restoring pavement and landscaping in the area.

During the week of November 20, concrete for the new curb between Spring Road and Hawthorne Ave. was poured, and access to homeowners' driveways facing Madison St. was restored. We also began patching asphalt in areas disturbed by the installation of the new natural gas and water mains. Parkway restoration will begin the week of November 27, after all asphalt patching has been completed, and will continue into December until weather conditions and sod availability prevent us from making any further landscaping restorations for the year.

Completing Our Work

After conferring with the City of Elmhurst, a decision was made to postpone the placement of the final asphalt layer on Madison St. until spring to ensure the street is safe for winter driving conditions. As soon as weather permits next year, the current pavement will be milled and a new asphalt layer will be placed so that any indication of street patching will no longer be visible. We apologize for the inconvenience but please know that we are committed to restoring the street and parkway to the same or better condition than when the project started.

Finally, as previously communicated, Nicor Gas and NPL will continue the replacement of the 20" natural gas main between Parkside and Kearsage Aves. in the spring.

For Your Safety

These improvements are part of the Natural Gas Consumer, Safety & Reliability Act and costs are recovered under the Qualified Infrastructure Charge. All Nicor Gas employees and contractors will have Nicor Gas, AGL Resources or Southern Company Gas-issued ID cards and will present them if requested. The Nicor Gas contractor working on this project is NPL.
