# Enhancements to your natural gas system in Elmhurst

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, has been working to modernize the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of the status of our work.

#### **Our Progress**

Since July, Nicor Gas' contractor, NPL has been working to install a new natural gas main in your neighborhood. Installation of a new 20" natural gas main between Hawthorne Ave. and Parkside Ave. is anticipated to be completed the week of October 2, 2017.

Pavement and landscaping restoration will begin soon after. Temporary restoration of some areas may be necessary until permanent restoration can be completed.

#### **Completing Our Work**

To ensure continued safe and reliable service to our customers during the fall and winter months, Nicor Gas will cease work on this project at Parkside Ave. in advance of the oncoming heating season.

The project will continue as planned from Parkside Ave. to Kearsage Ave. in the spring once heating demands are no longer a concern.

### For Your Safety

These improvements are part of the Natural Gas Consumer, Safety & Reliability Act and costs are recovered under the Qualified Infrastructure Charge. All Nicor Gas employees and contractors will have Nicor Gas, AGL Resources or Southern Company Gas-issued ID cards and will present them if requested. The Nicor Gas contractor working on this project is NPL.
