

**Nicor Gas** and their sub-contractors, **United Meters Inc.** (UMI) and **NPL Construction** (NPL), will be replacing the gas mains and gas services in your neighborhood to improve the dependability and integrity of your gas service. This project will consist of replacing approximately 22,000 feet of old low pressure cast iron gas main with new high pressure plastic pipe gas main and the replacement of 500 gas service lines including new gas meters and regulators. Preliminary work is scheduled to begin February 9, and all construction is anticipated to be completed by July 1, 2015, with final restoration to be completed by July 31, 2015.

The first phase of the project is to confirm the location of all existing residential and business gas service and meter locations. This work will be performed by UMI and is scheduled to start on February 9, 2015. UMI personnel will need access to affected properties in order to accomplish these tasks, as the existing meters are typically located near indoor piping. All UMI personnel will display a badge identifying them as a Nicor Gas subcontractor. If they are unable to obtain access to an affected property, a notice will be posted with their contact information so property owners can call and arrange an appointment.

Additionally, during this time NPL will begin inspecting the main sewer lines to determine the depth of residential sewer lines. If NPL is unable to view the residential sewer line they may need to gain access to your home's basement to visually determine the depth of your sewer line. Beginning February 23, 2015, NPL will begin the installation of new gas mains and gas services. Nicor Gas has hired USIC, a contract locating company, to locate all public utilities such as electric, water, sewer, and gas lines. They may come to your door asking for access to gas lines in your home to perform their locating work multiple times. They and all other Nicor Gas crews and hired contractors will have Nicor Gas-issued ID cards and will present them upon request. If you have any private utility lines, such as a sprinkler system, it is your responsibility to locate and mark those prior to construction. Nicor Gas is not responsible for repairs to unmarked facilities.

After the new services are installed, UMI will begin scheduling the installation of the new gas meters. The new gas meters will be installed outside and the old gas meter inside the property will be removed.

We understand that you value the appearance of your property. Permanent landscaping and pavement restoration will be completed on a continuous basis until the end of the project with final restoration to be finished by July 31, 2015. Parking restrictions will be posted as needed to provide a safe work zone for the employees performing the work. Flaggers will be used as necessary to assist pedestrians and vehicles through the work areas.

Construction hours will be Monday through Friday, 7:00 a.m. to 5:30 p.m. There may be times when construction crews will work on Saturday to maintain the proposed schedule.
