Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor KS Energy, will be modernizing the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of our work. Highlighted below are the major steps involved in the project that we will soon be starting in your neighborhood.

Our Progress

For the last several weeks Nicor Gas with its contractor, KS Energy, has been installing a new natural gas main in your neighborhood, and there is approximately 2000 feet of main left to install as part of this portion of the project. Due to the location of other underground utilities near the natural gas main along Waukegan Road, we will have to utilize a different excavation process than we normally use for this type of work. This process is called "open cutting," which requires us to cut into the street and/or parkway.

Completing Our Work

We will begin open cutting during the week of Sept. 3, 2019, and expect to complete the main replacement on Waukegan Road during the week of Sept. 23, 2019, weather permitting. During this timeframe, businesses on Waukegan Road will have limited access to their driveways and entrances, and signs will be put up restricting parking on the street. Impacted businesses will still be accessible to employees and customers throughout the project. To allow access to business' entrances during the workday, we will be placing temporary large steel plates on the street as needed. At the end of each day, we will temporarily backfill excavations made in the pavement.

Nicor Gas has been working closely with the Village of Glenview to ensure that this necessary work is completed safely and with as little disruption to you as possible. The Village of Glenview has granted Nicor Gas permission to use construction practices which will allow us to complete this work in a timely manner. We apologize for the inconvenience, but please know that we are committed to restoring the street and parkway to the same or better condition than when the project started.

After all of the new natural gas main has been installed in your neighborhood, we will contact you to schedule an appointment to move your meter outside of your business if it is currently inside and connect your meter to the new natural gas main.

For Your Safety

These improvements are part of the Natural Gas Consumer, Safety & Reliability Act and costs are recovered under the Qualified Infrastructure Charge. All Nicor Gas employees and contractors will have Nicor Gas, AGL Resources or Southern Company Gas-issued ID cards and will present them if requested. The Nicor Gas contractor working on this project is KS Energy.


