Our Progress


Nicor Gas, with its contractor NPL, has completed the installation of a new natural gas main in your neighborhood. In addition to installing a new natural gas main, we will be working to install new natural gas service lines which will connect each customer's property to the natural gas main. We anticipate this portion of the project will begin the week of Sept. 26, 2022 and be completed by the week of Oct. 24, 2022. Once the new natural gas service lines have been installed, we will complete landscaping and paving restoration and begin to retire the old system.

Completing Our Work

Nicor Gas and our contractors will begin permanent landscaping and paving restoration immediately following the installation of the new natural gas service lines and connection of the new natural gas system. We will also retire the old system. During the retirement process, Nicor Gas, with its contractor NPL, will be performing two small excavations in the neighborhood to access specific segments of natural gas main in order to retire the old system. We anticipate the retirement work to be completed by late 2022 or early 2023. We apologize for the inconvenience, but please know that we are committed to restoring the street and parkway to the same or better condition than when the project started.
