

# Enhancements to your natural gas system in Woodridge

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multi-year initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor, Precision Pipeline, LLC, is working to replace a portion of our natural gas transmission system located in your neighborhood and we want to keep you informed of the status of our work.

#### **Our Progress**

For the last several weeks Nicor Gas with its contractor, Precision Pipeline, LLC, has been preparing the construction area within the Nicor Gas and ComEd rights-of-way beginning north of 59th St. to north of 63rd St. in Woodridge where we will be replacing approximately 2,500 feet of natural gas transmission pipeline.


As part of this transmission pipeline replacement project, we will be operating

a boring machine located in the 63rd St. Park parking lot. This machine will be used to safely install the transmission pipeline underground with limited excavation and disturbance to residents.

#### **Completing Our Work**

Nicor Gas with its contractor, Precision Pipeline, LLC, will be taking all necessary precautions to ensure the safety of the construction area for residents and visitors of the Woodridge Park District facility. We will install orange safety fencing around the perimeter of the construction site, as well as clearly mark the construction area with appropriate signage and barricades.

As an additional safety measure, we will also install temporary chain link fencing around the perimeter of the 63rd St. Park parking lot, where the boring machine will be located. The Woodridge Park District facilities, athletic fields and bikeways are expected to remain open to the public throughout the project.
