Our Progress

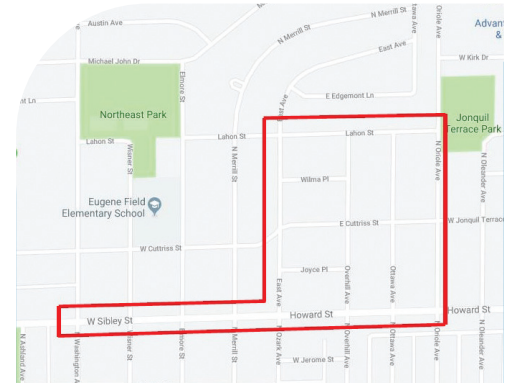
Nicor Gas, with its contractor NPL, has completed the installation of a new natural gas main in your neighborhood as well as new natural gas service lines which connect each customer's property to the natural gas main. Now that the new natural gas service lines have been installed and the new system is connected, we will begin to retire the old system.

Completing Our Work

As we work to retire the old system, Nicor Gas, with its contractor NPL, will be performing a limited number of excavations in the neighborhood to access specific segments of natural gas main as needed. We are utilizing temporary restoration to ensure that all areas affected during the retirement process are safe for residents as we work to finish the project.

Restore Landscaping & Paving

We understand that you value the appearance of your property. We anticipate this work to continue through the spring and conclude during or before July 2021. Permanent restoration will be completed once this project is finished. We apologize for the inconvenience, but please know that we are committed to restoring the street and parkway to the same or better condition than when the project started.
