## PROJECT POSTPONEMENT UPDATE – Sept. 2, 2022

# Enhancements

to your natural gas system in Elmhurst and Villa Park

Investing in Illinois: A Nicor Gas System Improvement Initiative is a multiyear initiative to modernize aging natural gas infrastructure. Nicor Gas, with its contractor NPL, will be modernizing the system that delivers natural gas safely and reliably to your neighborhood and we want to keep you informed of the status of our work. **We originally communicated that a new natural gas infrastructure modernization project would be starting in your neighborhood in August 2022. However, this project has been postponed.** 

## **Project Postponement and Rescheduling**

Nicor Gas, with its contractor NPL, originally anticipated beginning the installation of a new 1,875-foot segment of 16- and 20-inch natural gas main along Madison Street, beginning east of Route 83 in Villa Park, continuing east to Fairview Avenue and from Fairview Avenue to east of Hawthorne Avenue in Elmhurst, as outlined in red on the attached map, in August 2022. **Due to scheduling challenges as well as considerations for avoiding potentially disruptive construction and associated restoration work during the winter months, Nicor Gas and the City of Elmhurst have decided to postpone the project. We plan to revisit this project in the spring of 2023.** We will notify you once the project is rescheduled and we determine the new anticipated timeframe for the natural gas main replacement.

Construction equipment, materials and traffic control signage originally staged in preparation for the project will be removed over the next few weeks.

We sincerely appreciate your patience as we temporarily postpone this necessary natural gas infrastructure enhancement work.


